Speaker Erin Bickers-Loman-Ray Insurance Group - presenting Short-Term Voluntary Disability with Lincoln Fiancial:

This short-term disability policy is voluntary so the employees are responsible for pay 100% of their premium. January 1, 2017 will be the effective date with a 2 year rate guarantee. Erin Bickers handed out a comparison sheet showing the policy differences between IMRF, TRS & Lincoln Financial Group and Summary of Benefits for the plan. 15% participation from each district is needed in order to put this policy in place.
