Cost for is this program is \$6 per employee per month with November and December being free. Matt Marris will present again at November's meeting. #### Miscellaneous Items:

In the IERMP SPD, bariatric surgery is showing up on the preauthorization list and later on in the document it is listed as an excluded expense, so there is conflicting information. On the fully-insured side bariatric treatment was covered and when the IERMP was set up no group was going to lose benefits. Monticello CUSD #25 move and Heritage Community Unit School District #8 approved the bariatric surgery for the member (they must meet medical criteria) and amend the SPD to include bariatric surgery. Health Alliance will bring the amended SPD to November's meeting.

In the Plan document it is listed that each school district besides Edgar County uses BPC as a COBRA administrator. The attorney advised that each school district should use a TPA to administer COBRA to protect the trust. Every district needs to find out if they are using a TPA for COBRA. BPC will be contacted to find out which schools in the IERMP they administer. Also, the board needs to check with attorney to see if there is a form that a school can sign to opt out of holding the IERMP responsible if a school district doesn't handle COBRA correctly.
