### Financials:

**Adding schools to the IERMP:** There are a few schools who are wanting to get quoted into the IERMP. After much discussion, it was decided to go ahead and quote new districts. However due to the financials of the IERMP, Brian Loman needs to be very transparent with each district on the financial state of the IERMP.

**Moving audit year to a calendar year:** the auditor says he can do a 16 month audit in order to get the audit to be on a calendar year. The Executive Board stated it would make sense to do this and to do a long audit for this year.

**Items looking at for 2020 renewal:** Brian Loman informed the group items he's looking at for the 2020 renewal. He's looking at the copay structure, changing Rx copays for Tiers 4-6, adding a Triple Tier Network, adding/removing plans, having a preferred lab provider and the possibility of adding a 13<sup>th</sup> premium payment.
