## Financials:

Heritage Community Unit School District #8 moved and Paxton-Buckley-Loda Community Unit School District #10 seconded motion to approve financials through November 26, 2019. The financials show income as \$1,536,971.36 and total expenses totaling \$1,499,201.09 for an actual net monthly income of \$37,770.27. Balance in the trust account is \$79,934.14. Unpaid claims total \$1,060,615.08, total claims for the month total \$1,315,893.34. True trust balance is - \$980,680.94. Gail Heaton presented an Rx rebate check of \$198,836.72.

Speaker, Gail Heaton from Health Alliance, to go over the 3<sup>rd</sup> quarter report: Gail Heaton went over the 3<sup>rd</sup> quarter report for the IERMP. Rx claims are significantly higher than last year – up 21.66%. The group has 24 members with claims above \$75,000. Plan payment per member went from \$4,201 to \$4,672 compared to last year at this time.
