Approve December Executive Board meeting minutes:

St. Joseph-Ogden CHSD #305 and GCMS Community Unit School District #5 seconded the motion to approve the November Executive Board meeting minutes

Speaker Jim Baxter from TCOH to discuss PBM (Pharmacy Benefit Manager) contract:

Jim Baxter discussed how the transition is going with moving the PBM to CVS/Caremark. Jeremy Darnell gave an example of how TCOH was able to help one his employees with the transition of changing a prescription for the employee's daughter. There have been a few bumps with some members, but TCOH has been able to assist the members with their questions. The formulary with the new PMB contract is narrower than the one the IERMP had with Health Alliance, so there are some members who have had to change their prescriptions due to them not being covered under the new formulary. The members who are on the HDHP are experiencing some differences in the cost of their prescriptions starting 2021 due to the new contract and due to the fact they don't have copays for their prescriptions like the other plans. Members can use the GoodRx card if they can get their prescriptions at a lower price and submit the claim to apply it to their OPM. More discussion will happen in February.

Speaker Todd Reed from MetLife to discuss the ancillaries:

Todd Reed discussed the MetLife transition of the dental, vision and life. There were a lot of comments about the SSN numbers being used as ID numbers and some districts are not happy about that. MetLife explained that most major carriers use the members SSN numbers as ID numbers. Members don't have to put their SSN on their ID cards if they don't want to - it is up to the members. There is a nationwide system error which prevented providers to verify coverage for members, so MetLife was contacting providers directly for verification.

Some districts were behind on getting claim ready by January 1st, due to the fact of figuring out retiree definition for those districts who have retirees on their plan. MetLife is planning on having a follow up MetLink demonstration sometime in February so the bookkeepers can attend and ask questions regarding their MetLink account.

Financials:

Paxton-Buckley-Loda Community Unit School District #10 moved and GCMS Community Unit School District #5 seconded the motion to approve financials through January 28, 2021. The financials show income as \$1,701,297.09 and expenses totaling \$1,623,651.76 for an actual net monthly income of \$77,645.33. Balance in the trust account is \$758,873.51. Unpaid claims total \$0, total claims for the month are \$1,457,276.68.

Discuss 4th Qtr financial report - Kelly Grebinsky:

Kelly Grebinsky discussed the 4th Qtr financials. The 12 month operating gain is \$2,243,165 for 2020. Estimated total funding is down due to two items – the main one is from schools changing to lower cost plans and the other is less enrollment. Total incurred claims are lower due to the following reasons 1) plan migration 2) reduction of claims due to COVID & 3) lower medical trends than what were anticipated when rates were set last year. Incurred claims in the months of March – May 2020 were lower than normal due to the stay at home order. The number of high-cost claimants decreased from 83 in 2019 to 67 in 2020. Operating gain as of December 31, 2020 is \$753,861.

Update on Nurse Navigator and Strive for Five:

Brian Loman introduced the Nurse Navigator, Kris Elliott to the Executive Board. She has 25+ years at OSF and is very excited starting this new position. Marketing material is still being developed and hopefully everything will be finalized shortly. TCOH is currently working on password protected dashboard to have everything in one place – cost treatment calculator and cost for prescriptions.
