Financials:

Heritage Community Unit School District #8 made the motion and Fisher CUSD 1 seconded the motion to approve financials through September 21st. No expenses for the month of September. Total balance in the trust account is \$1,441,488.63 and \$174,017 in the wellness account.

Speaker, Dan Elsberg from The Standard, to discuss accident insurance, hospital indemnity and group critical illness insurance:

These are voluntary benefits for districts to offer to their employees. Must have 10 employees from each district to participate.

Ancillary presenters (had 20 minutes each to present):

Metlife – incumbent – 2024 renewal - dental 8% - 1 year, vision flat – 2 years and life flat – 2 years

BCBS – dental inline with renewal rates – 2 years, vision 5% under current – 4 years and life \$.024 lower than current – 3 years

The Standard – dental matching current 2023 rates – 2 years, vision 12% under current rates – 2 years and life \$.01 lower than current – 3 years.

BCBS is offering a \$250,000 transitional credit with the sale of all ancillary products plus up to -2% off of medical for those districts who offer vision and dental or life. Package pricing – dental -1%, life -.5% and vision -.5%. Vision must be elected with either dental or life to qualify for discount.

Discuss and vote on ancillary renewal for 2024:

St. Joseph-Ogden CHSD #305 made the motion and Heritage Community Unit School District #8 seconded the motion to approve going with The Standard for the 2024 ancillary
